Two or More Works by the Same Author in the Same Year. If you are using more than one reference by the same group of authors listed in the same year, first check to see if they have more specific dates (this recommendation is new to APA 7). Works with only a year should be listed before those with a more specific date.

APA style has a series of important rules on using author names as part of the authors and use the ampersand in parentheses. Citing an Author or Authors in the signal phrase or in parentheses each time you cite the work. Use the word "and" between the authors in the signal phrase or in parentheses. Citing an Author or Authors in the signal phrase or in parentheses.

Reference List: Author/Authors // Purdue Writing Lab Use "&" instead of "and." List the names of the authors in the order in which it is listed in the source. You can include up to five names of the authors, but in the subsequent in-text citation for works with more than two authors, write only the last name of the first author followed by et al.

Generally, if a work has multiple authors you must list all of their names in the citation entry on your reference list. In APA style, you list the last name followed by a comma, then the author's first initial and middle initial. For instance, an author named Francis Leanne Montgomery would be listed as "Montgomery, F. L."

For 2 authors in an APA citation of journal, first give the information for the first author followed by a comma, then use an ampersand (&) before the final author name.

Journal Article with Two Authors - APA Citation Style, 6th ... Provide all the authors' last names when you first refer to a document with 3-5 authors. Only list the first author with the Latin abbreviation "et al." for any subsequent references.

In-text: Multiple Authors - APA Citation Style Guide (6th ... NOTE: The in-text citation for works with three or more authors is shortened to the first author's name, followed by et al. and the year.

Journal Article with 3-7 Authors - APA Citation Style, 7th ... The following rules for handling works by a single author or multiple authors apply to all APA-style references in your reference list, regardless of the type of work (book, article, electronic resource, etc.). Single Author. Last name first, followed by author initials.

Though the APA's author-date system for citations is fairly straightforward, author categories can vary significantly from the standard "one author, one sources, electronic sources, and sources without page numbers. Citing Non-Standard Author Categories

In-Text Citations: Author/Authors // Purdue Writing Lab Order the citations of two or more works by different authors within the same parentheses alphabetically in the same order in which they appear in the reference list (including citations that would otherwise shorten to et al.). Separate the citations with semicolons.

How do you cite two or more references within the same ... NOTE: If your reference has three to six authors, cite them all the first time mentioned in your paper. After that, use the first author's last name, followed by et al. and the year).

Journal Article with 2 Authors - APA Citation Style, 7th ... Books with Three to Five Authors (THIS Libguide IS FOR APA 6th edition, click here to visit our new APA 7th edition Libguide) The formatting guidelines below refer to books with three authors. If the book has four or five authors, you would follow this format and add the fourth and fifth author's after the third.

Three to Five Authors/Editors - APA Citation Style, 6th ... Multiple Authors - 20 Authors or Less? For one or two authors, list all authors in the reference. For three or more authors, list the first author followed by et al. This includes the first time the source is used in the paper.

Journal Article - Citation Help for APA, 7th Edition ... Surnames and initials for up to twenty authors should be provided in the reference list. For more than 20 authors, list the first 19, followed by an ellipses, then list the final author.

Journal Article 7 or more Authors - APA Citation Style ... Works by two authors should list the last names and first initials separated by an ampersand (&). These names should be followed by the date of publication enclosed in parentheses. If the work is a journal article, the title of the article should immediately follow the publication date.

How to Reference Authors in APA Format Narrative citation: Freeberg (2019) The foundation of the reference is the same as for a journal article. Include the description "[Supplemental material]" in square brackets after the article title. If you cite both the main article and the supplemental material, provide only a reference for the article.
