THE OBJECTIVES AND PRINCIPLES OF THE TRIPS AGREEMENT

TRIPS stipulates that reviews of the agreement itself must be carried out every two years by a body set up within the WTO — known as the Council for TRIPS — that is open to all member states. Any revisions of the text of TRIPS can take place either immediately following one of these reviews or, more likely, at the conclusion of a new round of trade negotiations.
